## CERTIFICATE OF INCORPORATION

- I, WM. S. O'BRIEN, Secretary of State of the State of West Virginia, hereby certify that an Agreement, duly acknowledged, has been this day filed in my office, which agreement is in words and figures following:
- I. The undersigned agree to become a corporation by the name of \_\_\_\_\_\_\_ THE CHERRY RIVER NAVY, INC.
- II. The principal Office or Place of Business of said Corporation will be located in the city of Richwood, in county of Nicholas and State of West Virginia. Its chief works will be located at the same place.
- III. The objects for which this Corporation is formed are as follows:

To provide a legalized and organized means of controlling, regulating and perpetuating the Cherry River Navy as an organization to serve as a medium of publicity and good will for the interests of West Virginia through recognition of individuals by such organization who have or may contribute directly or indirectly to the welfare of the State or any of its subdivisions, municipalities or communities.

To obtain and use and govern the use of any buildings or materials essential to the general purposes of the Cherry River Navy and to sell or dispose of same.

To govern and regulate the Cherry River Mavy against individual exploitation either of the name or the membership of such organization.

for such other purposes in general as may from time to time to the members and directors seem fit and proper for the better carrying out of the purposes of the Cherry River Navy or to be carried on in connection therewith.

TV. This Corporation is being organized as a non-profit corporation. Membership in said corporation shall be confined to the incorporators and such others as these may, from time to time elect.
